

Water Act 2000 – Form W2F081 ABN 51 242 471 577 Notification form for accepted development for subartesian water bore

Purpose of the form

This form is used by landowners to notify the department of the construction of a replacement water bore that meets the requirements for accepted development. Notification of works must be received within 60 business days after construction of the bore has been completed.

If the bore is less than six metres deep and was not drilled by a licensed driller, Part D Construction details of new or replacement bore must be completed.

If the bore is more than six metres deep, it must be constructed by a licensed bore driller and a copy of the drill log must be attached to this notification.
