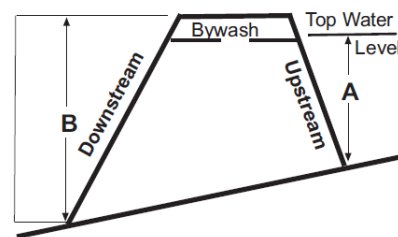

Guideline for an application to amalgamate, amend or subdivide a water licence

Purpose of the form

The application form is a document approved for use within the state of Queensland under the provisions of the *Water Act 2000*. Under this legislation, the licensee of a water licence may apply for one or more dealings on their water licence.

This form is used where the applicant has an existing water licence and wishes to do one or more of the following water licence dealings:

- amalgamating two or more water licences attached to the same land
- amalgamating the taking and interference, if the take is from the storage created by the interference
- amending a water licence
- subdividing a water licence into two or more water licences
- transferring a water licence in conjunction with one of the above dealings

Unless otherwise indicated, all parts of the form should be completed. The department may require the applicant to provide additional information. You will be contacted if additional information is required.

Applicants are advised that if the application does any of the following it will require public notification under section 130 of the *Water Act 2000*

- increase the amount of water that may be taken
- increase the daily rate or maximum rate per second at which water may be taken
- change the location of taking or interfering with water, unless the dealing is permitted under a regulation or water management protocol
- increase or change the interference with water
- add, remove or change a condition on a licence.

The applicant should contact their local departmental business centre if they have any questions relating to this requirement or any other legislative questions or additional details that may be required before submitting the application.

It is the responsibility of the licensee(s) to ensure they have the necessary approvals to gain access to water authorised under their water licence. Approval of this application does not authorise construction or installation of new works or any associated development. Further information relating to the assessment and approvals of works to take or interfere with water can be accessed at www.business.qld.gov.au.

Part B Water licence dealing(s) types

This part is used to specify:

- water licence number(s) and water licence type the application relates to

2. Type of dealings

(a) To amalgamate two or more water licences

To amalgamate two or more licences into a single water licence, the water licences must relate to the same land. If the licences do not attach to the same land, you can apply to amend the description of land (where the water is to be used) so the licences relate to the same land. Then you may apply to amalgamate the water licences.

(b) To amend a water licence

(b)(i) Amend the description of land by either adding or removing land

If the application is to amend the water licence by either adding land, or removing land to which the water licence attaches, the application **must** be accompanied by written advice from the applicant. This advice needs to state they have given notice of the application to any entity that has an interest in the land to which the water licence attaches.

Who is an entity with an interest in land to which the water licence attaches, where the land is being added or removed from a water licence?

Under the *Act Interpretation Act 1954*, an entity with an interest in land is any person, corporation or unincorporated body who has a legal or equitable estate in the land, or a right, power or privilege over, in relation to the land. Under the *Acts Interpretation Act 1954* a reference to a person with interest in land includes a reference to a person as proprietor, transferor, transferee, mortgagor, mortgagee, lessor, lessee, trustee or as having an interest in land includes a reference to the person's personal representatives, successors and assigns.

The notice **must** include the following information:

- a description of the proposed changes to the land to which the water licence attaches
- where copies of the application may be inspected.

The applicant must within 10 business days of giving the notice to an entity give a copy of each notice to the chief executive of the department.

To identify where copies of the application may be inspected refer to:

- the water management contacts listed at www.business.qld.gov.au
- the office contact details listed on your water licence.

Part C Water licence details

This part is used to specify the details of the water licence(s) being applied for.

Part number

If subdividing each part must be given its own number. For example: each copy of Part C must be given its own unique application number, i.e. 1, 2 or 3. The number of Part C's must equal the number of proposed water licences stated in Part B.

Applicant name

To make an application the applicant must be the owner(s) of the parcels of land entered in the description of land on the form. If the licensee details listed in Part A and the applicant name listed in Part C differ, a transfer is required.

An 'owner' of land is defined under section 104 of the *Water Act 2000*.

Amount of water

Indicate in megalitres or hectares the amount of nominal entitlement to be given to the proposed water licence.

If the water licence is in an area covered by a water plan and if that plan or associated water management protocol does not allow a decision that would increase the average volume of water available to be taken in the plan area, then the amount may only be equal to or less than the nominal entitlement on the current water licence.

Fees and charges

The prescribed fee payable at the time of application is changed each year with the consumer price index (CPI) which takes effect from 1 July each year. If submitting an application immediately following 1 July contact your nearest departmental office to obtain details of the current fees.

Lodgement

Contact your local departmental office specialising in water applications for lodgement information. These details are listed on your water licence. Water management contacts are also available on the Business Queensland portal at www.business.qld.gov.au.
