

**Water Act 2000**  
**Barron Water Plan Area Draft Water Entitlement Notice**

This is a draft Water Entitlement Notice made by the chief executive on 6 July 2022 under the authority of section 71 and 72 of the *Water Act 2000*. All individual water licence related information is current from 24 June 2022.

**Water entitlement notice**

- (1) For section 71 of the Act, the chief executive may at any time, make a water entitlement notice for the plan area.
- (2) For subsection (1) above, the notice may state the draft entitlements or other authorisations that have been repealed or amended under this plan in accordance with parts 1 to 2.

**Part 1 Repealing a water licence—*Water Act 2000*, section 133**

The chief executive may, for the purpose of implementing a water plan, consistent with section 70(1)(g) of the *Water Act 2000*, repeal a water licence in accordance with part 1, Schedule 1 of this Draft Water Entitlement Notice. In accordance with section 103(a) of the *Water Act 2000* and section 29 of the draft *Water Plan (Barron) 2022*, the licence is no longer necessary to authorise a particular take of water.

The repeal takes effect from the day the chief executive gives the licensee notice of the repeal.

**Part 2 Amending water licences—*Water Act 2000*, section 133**

The chief executive must, consistent with Part 7 Division 5 Subdivision 3 of the draft *Water Plan (Barron) 2022*, amend each of the existing water licences as specified in accordance with this notice-

- Part 2, schedule 1, Licences for taking unsupplemented surface water.
- Part 2, schedule 2, Licences for taking unsupplemented surface water.

The amended licence takes effect from the day the chief executive gives the licensee the amended licence.
