

Horticulture Irrigation Pricing Rebate Scheme results to June 2023


Overview

- Since the start of the scheme in 2021 to 30 June 2023, 795 applications were approved by the Queensland Rural Industry Development Authority (QRIDA). Approximately \$3.6 million was paid to Sunwater and Seqwater irrigation customers.
- QRIDA approved 98% of applications received. QRIDA works with unsuccessful applicants to review the information requirements to assist them with future applications.

Location of recipients

Irrigators in the Wide Bay Burnett area have been the largest recipient of payments with almost \$2.2 million paid to customers.
