## Water Entitlement Notice for Water Plan (Mary Basin) 2024

This is a Water Entitlement Notice for the *Water Plan (Mary Basin) 2024* made by the chief executive on 09/05/2024 under the authority of sections 71 and 75 of the *Water Act 2000* (the Act). The matters implemented by this notice are to have effect from 9/05/2024. This information is current as at 09/11/2023. (Please note: This Water Entitlement Notice may not include changes resulting from any type of water licence dealings that have occurred since 09/11/2023.)

### Water entitlement notice

1. For section 71 of the Act, the chief executive may at any time, make a water entitlement notice for the plan area.
2. For subsection (1), the notice may state the entitlements or other authorisations that are to be converted, granted, amended or replaced under this plan in accordance with parts 1 to 5 of this notice.

#### Part 1 Conversion to a water allocation – *Water Act 2000*, section 1271

The chief executive may, consistent with sections 70(1)(a) and 1271 of the Act, convert interim water allocations to water allocations in accordance with part 1, schedule 1.

The water allocation takes effect from the day the registrar records the details of the water allocation converted on the water allocation register.

#### Part 2 Grant of a water allocation – *Water Act 2000*, section 147

The chief executive may, consistent with clause 51 of the *Water Plan (Mary Basin) 2024*, grant a water allocation in accordance with part 2, schedule 1.

The water allocation takes effect from the day the registrar records the details of the water allocation granted on the water allocation register.

#### Part 3 Granting of a water licence – *Water Act 2000*, section 116

The chief executive may, consistent with clause 39 of the *Water Plan (Mary Basin) 2024*, grant a water licence in accordance with—

- Part 3, schedule 1 for taking water from a watercourse
- Part 3, schedule 2 for taking underground water.

The licence has effect from the day the licence is given to the licensee.

#### Part 4 Amendment of a water licence – *Water Act 2000*, section 133

The chief executive must, consistent with clause 43 of the draft *Water Plan (Mary Basin) 2024*, amend water licences to take water with purpose 'any' or 'stock and domestic' in accordance with part 4, schedule 1.

The chief executive must, consistent with clause 43 of the draft *Water Plan (Mary Basin) 2024*, amend water licences to take water with purpose 'urban' in accordance with part 4, schedule 2.

The chief executive must, consistent with clause 49 of the draft *Water Plan (Mary Basin) 2024*, amend water licences to interfere in accordance with part 4, schedule 3.

The amended licence takes effect from the day the chief executive gives the licensee the amended licence.

#### Part 5 Replacement of a water licence – *Water Act 2000*, section 133

The chief executive must, consistent with clause 40 of the draft *Water Plan (Mary Basin) 2024*, replace water licences to take water in accordance with part 5, schedule 1.

The replaced licence takes effect from the day the chief executive gives the licensee the replaced licence.
