Notice of works – underground water

Purpose of the form			
<p>This form is used for the notification of works that take underground water. The information in this notice is required to authorise continued take of underground water in the notice of work area.</p> <p>Water plans specify that owners of existing works are authorised to take underground water for a purpose other than stock or domestic for a specified period after the commencement of the plan. In order to be authorised to continue taking water, the owner must give notice of the existing works to the chief executive within the period specified in the water plan. Any continued take of water without notifying the chief executive of the existing works is an offence under the <i>Water Act 2000</i>.</p> <p>Notification is not generally required for existing works taking underground water for only stock and domestic purposes.</p>
